

AGREEMENT

1. In consideration of the camper's enrollment and the payment of the appropriate fees Lana's Summer Camp d/b/a/ Lana's Gymnastics Club, Inc., will provide tuition and maintenance for the camper.
2. Tuition includes regular camp program instruction, supervision, and transportation to or/and from camp, transportation for trips, pool and park entry fees, board while at camp, one (1) camp's T-shirt.
3. **Tuition fees do not include registration fees, any trips or activities outside of camp, physicians' fees, hospital fees, or medicine other than provided by standard camp emergency procedures.**
4. **IT IS UNDERSTOOD AND AGREED THAT MY CHILD MAY PARTICIPATE IN ANY ACTIVITIES INCLUDING SWIMMING IN THE POOL AND TRIPS ORGANIZED BY THE CAMP STAFF OFF OR ON THE CAMPGROUNDS. MY CHILD MAY TRAVEL WHEN DEEMED NECESSARY WITH THE CAMP, VIA PUBLIC CARRIER, OR DESIGNATED CAMP VEHICLES.**
5. A deposit of \$200.00 (Two Hundred Dollars) must accompany this application. These balances of all fees are payable prior to the camper's scheduled first day of attendance. Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., **RESERVED THE RIGHT TO REFUSE ADMISSION TO ANY CAMPER FOR WHOM PAYMENT HAS NOT BEEN RECEIVED** prior to the camper's scheduled first day of attendance.
Expenses incurred during camp season shall be due and payable ten (10) days after mailing of statement of expenses. The camp shall have further right to charge and receive collection of attorney's fees on any unpaid balance plus interest, expenses and court costs, if any, in the event that the camp initiates proceedings for the collection on any unpaid balance due.
6. No adjustments, allowance or refund of the deposit or balance of the tuition fees shall be made except in strict conformity with the rules:
 - a) Where a parent of a camper notifies Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., prior May 1, 2010 that he or she will be unable to attend for any reasons whatsoever, a full refund will be made of all fees previously paid less a non-refundable registration fee of \$45.00 (Forty Five Dollars).
 - b) Where a parent of a camper notifies Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., prior to June 1, 2010 that the camper is unable to attend because of injury or illness, properly documented, all money received on behalf of the applicant will be refunded less a processing and enrolment expense of \$100.00 (Hundred Dollars).
 - c) All requests for refunds must be in writing.
7. For the safety, welfare and proper maintenance of all the campers, Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., reserves the right to dismiss a camper whose conduct or influence is inimical to the best interest of the camp in the considered opinion of the directors. Such conduct or influence includes, but not limited to, the following: an observation or discovery of, the use of, the possession of, drugs or drug-related implements, stimulants or intoxicating beverages, bringing food on camp, leaving camp or off camp activities at any time without official approval and supervision. Damaging or defacing of camp property, smoking and omission or misrepresentation regarding the medical or mental history of a camper. Any of the above conduct may subject the camper to dismissal. In such an event there will be no refund or adjustment of any part of the camp tuition.
8. Camp director will assess defacing or damaging of camp property and all costs for repairs will be charged to campers account. Expenses will be deducted from remainder of security deposit. If expense exceeds balance left in account will be billed accordingly.
9. Due to the seasonal nature of summer camping, no refund or credit will be made for any portion of the camping period not completed, including late admission, early departure (leaving), and dismissal for cause, disability or withdrawal for any reason. Tuition and fees already paid and or due is agreed to be the fair and reasonable sum as and for liquidated damages. All claims for refund or credit are expressly waived and released by the parents and or guardian of the child.
10. Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., its officers, directors, and employers, shall not be responsible for clothing or personal possessions lost or damaged by fire, theft, malicious mischief or personal negligence.
11. **In case of Emergency the undersigned hereby gives permission to the physician or hospital selected by the camp director to hospitalize, secure proper treatment for, and to order injection, anesthesia, X-ray or surgery for my child and parent/guardian will be responsible for all payments for this services. I understand that Lana's Summer Camp d/b/a Lana's Gymnastic Club will make every effort to contact my emergency contact or myself before or immediately after such emergency treatment is rendered.**
12. Permission hereby granted to Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., to use any photograph, film or video, of the above camper in any public release, publicity, advertisements of brochure, television program or promotional video, website of Lana's Gymnastics Club, Inc.
13. If Parent decides to withdraw his or her child, the directors require 24-hour notice. The child may be picked up from campsite only.
14. Parent/guardian further agree to waive the right to press legal charges against Lana's Summer Camp d/b/a Lana's Gymnastics Club, Inc., its officers, directors, and employers, in those instances where any of the above have not clearly demonstrated negligence leading to injury of the above named child.
15. The camp assumes no responsibility for the acts done by campers when in violation of camp rules, local, state or federal laws. The camp is not responsible for losses of personal property or acts done by campers or other persons while off camp's premises. Parent/guardian will be responsible for any damages incurred by camper on or off camp premises.

**Lana's Summer Camp is required to be licensed by the New York City Department of Health.
In addition Department of Health inspects Lana's Summer Camp once a year.**
